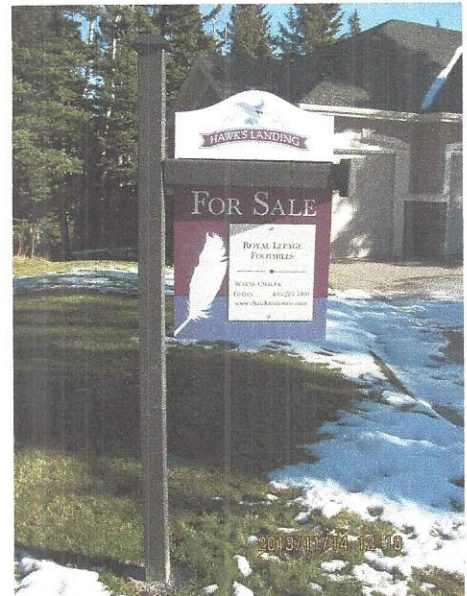

**Rental Conditions:**

- ~ Signs, including the insert with any Realtor name, shall remain the property of Hawk's Landing Services Co-op Ltd. (HLSCL).
- ~ Renter is responsible for all damage to signs, irrespective of how caused, other than through the express negligence of an agent of the HLSCL.
- ~ The Renter shall advise HLSCL when the Residence is sold and all signs will be removed within 7 days of the sale of the home.
- ~ Temporary sandwich board signs will only be allowed for a maximum of 7 days after the sign is ordered, if left longer, will be removed by the HLSCL.
- ~ If any payment is dishonored by the Renter's bank, the HLSCL shall have the right to forthwith reclaim all signs rented by that Renter, without further notice.
- ~ The Realtor or the Homeowner shall not modify, install or remove the signs under any circumstances. Only the agents of the HLSCL shall perform those duties.
- ~ Sold stickers shall be of approved form only so as to not damage the sign.
